



STARTIP ACQUIRES A 7.9% STAKE IN ALKEMY

(“StarTIP”) announce the subscription at the IPO of 425,000 shares of Alkemy S.p.A. with an investment of approximately Euro 5 million reaching a share of approximately 8%, becoming one of the major shareholders.

Today Borsa Italiana S.p.A. released the provision for admission to trading of the ordinary shares of Alkemy S.p.A.

Alkemy aims to support senior management of mid-sized to large Italian and international organizations in their processes of digital transformation of the company, of their business models and their interaction with consumers through the design, planning and implementation of innovative solutions and projects aimed at developing and renewing their businesses. The transaction took place in the context of the innovation and digital project, which foresees the concentration in StarTIP of all the shareholdings operating in the start-up, digital and innovation fields, i.e. Digital Magics, Talent Garden, Telesia and others, companies that have already passed the early stage.

Up to Euro 100 million are allocated to this project, to be invested in further initiatives in such fields convinced that uniqueness and peculiarities of TIP Group, of its network of entrepreneurs, family offices and of its investee companies can support significantly the acceleration of the development of really innovative companies.
